1. WELCOME AND INTRODUCTION

5. ADVISORY GROUP - SOCIETY AND COLLEGE OF RADIOGRAPHERS STRATEGIC OBJECTIVES (update)

SH gave an overview on SCoR.

Every three years the strategy is reviewed to reflect what is happening in radiography as a whole. Members of the UK Council of the Society of Radiographers and the College Board of Trustees (CBoT) along with Managers, Directors and a selection of staff attended events in October to develop the strategy. This work should be presented in the New Year. Advisory groups support delivery of the strategic plan.

- Advanced Clinical Practice publication of framework for England
 - Considerable debate around the challenges in this framework for those in roles, who may not have current formal qualifications. Discussion around impact on pay and job evaluation and the differences between SCoR strategy and the national document.

- Scope of practice assistant practitioners,
- Working party agreed to develop this work
- Annotation on digital images issue via consultant radiographer group
 - It was not felt professionally appropriate to have images with 'side markers' encased in 'fun' shapes e.g. skull or lego men where these can be seen upon the image. Concern around where they may cause artefact on soft tissues leading to misdiagnosis and the potential for the images to be used in legal cases calling the professionalism of the radiographer into account.

- Workforce promoting professionalism, reforming regulation consultation document
 - Reasonable in depth look at the consultation document ensued. The role of the Professional Standards Agency in managing assured voluntary registers was discussed. The risks of being 'deregulated' and potential impact on the profession were explored and this was not seen to be desirable. Concern that few members would respond and some would consider it a money saving opportunity.
