

# Radiotherapy Advisory Group (RAG) Work plan 2018 - 2019

#### **CONTEXT:**

RAG is appointed by UK Council to provide profession specific advice about issues impacting upon therapeutic radiography and its context within cancer services.

Membership of RAG is drawn from a range of practice areas including clinical practitioners, managers, educationalists and researchers across the four UK countries.

## **RATIONALE:**

- Improving outcomes for cancer is a priority for Health Services and a significant component of the government's modernisation agenda for healthcare. Rising incidence and wider recognition of the role of radiotherapy, technological developments and increased consumer expectations have combined to create an urgency to change patterns of practice.
- Therapeutic radiographers and the wider radiotherapy workforce working within this technologically sophisticated care environment must be supported and developed to be able to maximise their individual and collective potential in delivering the best care for people with cancer.
- Since its inception in 1995, RAG has made a significant contribution to the development of the profession and in raising its profile nationally. It is an effective voice for the community of therapeutic radiographers and the wider radiotherapy workforce

# **RAG OBJECTIVES:**

The role of RAG is to provide the Society and College of Radiographers with advice regarding strategic direction for the profession and appropriate support to deliver service improvements within the inter-professional environment of cancer care with a remit of:

- To provide advice and information relating to the continuing education and professional development needs of therapeutic radiographers and the wider radiotherapy workforce and to the pressures and developments of the service.
  - o E.g. Developments for quality standards within radiotherapy
  - o E.g. Apprenticeship development
  - o E.g. Conduit for various Radiotherapy Special Interest Groups RTQSIG
- To promote explicit career development pathways, in line with organisation policy, for therapeutic radiographers and the wider radiotherapy workforce across all aspects of the profession both inside and outside of radiotherapy centres



# RAG OBJECTIVES cont.

- To facilitate research and guideline development for publication by The Society and College of Radiographers
