Discussed date/venue for next year's meeting. All agreed that SCoR HQ was an excellent venue, easy to get to and not too expensive if timing OK for off peak travel. Date chosen Wednesday 19th June 2013.

- 3. Glenda Logsdail- gave an overview of presentations at the GEC-ESTRO/World Congress May 2012 relating to prostate and breast brachytherapy. Lively discussions were had around the topic of brachytherapy for focal prostate treatment and monotherapy. Peter Hoskin had presented on monotherapy, manageable urinary toxicity, possibly greater need for re-cathetrisation after 19 Gy single fraction. Promising biochemical results for patient given 26Gy.
 Clare (Leeds) said that they had used brachytherapy for salvage prostate treatment after EBRT.
 Images shown of focal therapy. Breast brachy- techniques discussed.
- 4. Rachel Kirby gave an overview of presentations at the GEC-ESTRO/World Congress May 2012 relating to Gynae and miscellaneous brachytherapy. This promoted a lot of interest and questions from the group, discussions re MRI planning for ca cervix and implementation of ESTRO/ RCR guidelines.
- 5. Andy Clarke from Nucletron gave a presentation breast brachytherapy techniques.
- 6. David Wood (Christie) gave an informative presentation on PDR Gynae brachy and the Christie experience in setting this up.
- 7. Heather Dias spoke about her experience of the Bristol brachytherapy module 2011 and the essay that she had written for this.
- 8. Michelle Cook from Varian- Update on integration of iX brachytherapy software with the Brachyvision planning software and Aria radiotherapy information system.

- 9. Pauline gave a presentation on the new international guidelines for use of dilators. Discussion about lack of evidence base for this. Karen (Poole) said that they will be doing an audit of compliance, but perhaps could increase this to try and assess effectiveness of dilation.
- 10. Clare led a discussion on prostate fiducial markers. She talked about setting up a radiographer led fiducial marker service. The centres already doing this service had various ways of doing it, from general anaesthetic to nothing (something to do with southern softies!). The majority did the procedure trans-rectally using ultrasound. The consensus was that the procedure was very quick to perform and improved the accuracy of the EBRT treatment.

Meeting closed at 17.30 hrs.
