## 1. WELCOME AND INTRODUCTIONS

## 4. **GROUP MEMBERSHIP**

- 4.1 SJ gave an update to the group and it was noted that technically all vacancies are filled. When the group formed in 2017 all modalities were covered as well as all 4 countries. But as time is going on it is not so easy to get all the countries and modalities represented and as an organisation we have a more devolved health agenda. We are an advisory group for the UK Council and we need to feed in to them. It is important at all 4 countries are represented. Helpful to hear member's views.
- 4.2. Leandre Archer representing Northern Ireland and TUIR struggles to attend and we lost our Scottish representative when Jonathan McConnell left. Richard Newman was appointed as a NQR and is now an advanced practitioner. We had 2 assistant practitioners and now only have 1. GT is happy to put out an expression of interest in Wales with the view to getting some welsh clinical representation as he is in academia (and attends as UK Council rep) and also mention at the next UK Council meeting.

Following discussion it was felt that the terms of reference for the group need a tweak to show what representation on the group is. The synergy between the professional team and industrial relations team representation is vital. SJ will speak with Charlotte Beardmore (Director of Professional Policy) and will keep the group updated.

Would it be practical to advertise for a representative from each of the devolved nations? The group agreed that having a TUIR officer on the group would be of beneficial. Further discussion on next agenda.

Roundtable update on the current situation and issues.

Northumbria (DH) Local recovery plans are up to date with CT, although ultrasound has struggled a bit. All students to go home for Christmas, but a few may be on placement which is a bit of concern. Some issues around staff off sick and self-isolating. A discussion around Covid testing for NHS workers. Government designated students as key workers. Recovery plans for students and getting them home for Christmas has had an impact. All students being tested now but lots of students might lose placement time if they go home. If tested positive they will not be able to travel.

Quite a few people who do not want to do the test. In some trusts some international students not designated as key workers. Some trust doing well with their backlog. Very varied testing picture across the country.

Lateral flow test is only 57%. PCR test is very sensitive and specific but this takes several days.

Regional recovery plan/models – adopt and adapting the things that work well during the first lockdown. Regions all talking to each other but not much else as everyone is trying to cope with their various issues.

Nightingale Hospitals – not much to report on this. Harrogate is open but not for Covid patients only rehab and post op patients. The London Nightingale is not open. Big issue is that the workforce to run the hospitals is just not there.

Health and wellbeing support – Hearing quite a lot about burnout from members. Is there anything SCoR as an organisation can do to support members? An issue at one trust with some out-patients who do not have a medical issue but refuses to wear a mask just because they do not wish to do so. A suggestions was made of staff wearing full PPE when treating these patients. Some trusts are having facilities such as yoga, online help, and the student unions have been very proactive. A lot of good things happening to support and assist.

Academic support is really feeling the pressure and it was good to hear that universities are providing support.

Some final year students are getting worried that they will not have enough knowledge when they qualify, but have been told that the preceptorship will cover this and that they will be supported. It would be good to have a national approach as retention is key.

Key points: All students having Covid tests to get them home for Christmas Clinical training time is likely to be lost Preceptorship for NQR's is going to be of greater importance this year There is a very mixed picture on recovery plans and reducing waiting lists; staff is the limiting factor Network/regional co-operation is not recognised at the frontline Investment in further training e.g. CT is welcome but really challenging without backfill Wellbeing of staff is a big concern

SJ gave a brief overview on workforce. NHSEI and HEE are working closely together with much less duplication nationally and regionally. The new National Clinical Advisor for Radiology is Dr Sam Hare. Suzanne Rastrick is the chief AHP and they jointly chair the Imaging Workforce Group. Lots of groups sits under this umbrella and every region has a voice. Links with other networks are also developing.

There is a programme of work around international recruitment and the career and education framework. In the SW 144 radiographers have been recruited from Dubai. In the London region there is a focus on standardising the work of reporting radiographers and standardising the role of the support workforce in CT.

There is a new England project about to start on the diagnostic support workforce funded by HEE. Penny Owens will be working on the project on behalf of SCoR. This work is linked to the competency frame work for the support workforce and should have output by the end of March next year. Hopefully HEE will provide the money to carry out the work following the project outcomes.

AL stated the workforce census not getting great returns, and asked the group to please promote to managers and departments and hopefully we will get the return.

## 11. IMAGING TRANSFORMATION PLANS

National Imaging Optimisation Board Transformation Plans – Sam Hare has taken over as Chair from Erika Denton and the main emphasis at the last couple of meetings was on the Mike Richards report with the discussion around staff, equipment and diagnostic hubs. At the last meeting a cardiologist spoke on cardiac imaging and network plans. It was noted that some trusts covers on-call to midnight and it was questioned as to whether there actually is a need for this midnight service. No data on what this cover is throughout the UK.

Regional Imaging Networks – Regional imaging networks still developing and evolving with trust getting together. Nationally most people are happy with how their network will function. PACS managers will need access to data.

b) Education and Career Framework (ECF) - Education and Career Framework – this is ongoing with the Delphi study due to finish around 16<sup>th</sup> December. SJ gave a brief update and also commented on filling in the questionnaire. Feedback box has a bit of a glitch. So SJ advised group to type feedback on a word document and then copy and paste. It seems to accept copy and paste quite easily.

Kerry Mills (radiographer from UWE Bristol) gave a presentation on workforce focusing on the assistant practitioner role in MRI. MRAG is currently working on a updating an MR document which will be published in the document library and will set out examples of MRI. IPEM has just launched a role based MRI certificate scheme which is open for all radiographers and radiologists to apply for. Currently working on a suite of work based eLearning modules. Also updating safety guidance document but waiting for the g for the MHRA who is currently on hold.

- f) Heads of Radiography Education (Stuart Mackay) SMac informed the group that the latest meeting was held on 27<sup>th</sup> October but he was still waiting for the minutes. A lot so discussion around the subject of students going home for Christmas. Has been doing some work with Gill Holroyd on universities working collaboratively. A matrix of programmes currently running and those about to run was produced and was well received at a national meeting. There is a need to collaborate as a profession. SMac will be having further discussions and will report back progress at next meeting. There was concern around new providers coming onto the market. Had some reports from some of the people who are evaluating the programmes and has discussed this issue with Beverley Harden Chief AHP. HEE next plan is to go to HCPC and try to do some influencing there. Prospective students who wish to apply for a radiography course are usually asked to have a clinical visit before they apply, and there was going to be a discussion as to whether there really was a need for this, but then Covid struck, so this is on hold. SMac will give feedback at the next meeting.
