### 1. WELCOME AND APOLOGIES

1.1 The Chair warmly welcomed everyone to this virtual meeting of CRAG.

### 2. APOLOGIES

2.1 Apologies received from Nicholas Barlow, Conor Fitzgerald, Valerie Middleton, Kim Ngu and Laurence Skermer.

### 3. MINUTES

3.1 *Minute 4.1* – Advanced Practice (Impact work and spread of roles) – TOR informed the group that this is ongoing and will follow up with Rachel Harris (RH) and Spencer Goodman (SG). TOR further informed the group that when she last spoke with SG, he indicated that a multi-professional framework was being developed for radiotherapy advancing practice. If there is anything to share from SG, she would ask for permission to share on synapse.

3.2 *Minute 5.1* – CRAG Guidance Document – It was agreed that this should be left with Stella Campbell (SC) for completion. The document will then go to proof-readers and on to SoR council for their approval prior to publication.

- 3.3 *Minute 11.1* – Website – TOR informed the group that she has updated the CRAG webpage. Blu Evans (Content Editor) and Felix Haigh (Learning Technologist) will be available to update, make changes and offer advice with respect to page design. SC asked if the publications in the document library could be listed alphabetically or some kind of order to help with searching. TOR will check if this can be applied.

- 3.4 *Minute 11.2* PCE guidance (formerly ‘red dot’) – is ongoing but running a bit behind schedule. TOR reminded the group that the Diagnostic Imaging Advisory Group (DIAG) had on their workplan to work on preliminary clinical examinations and this guidance (formerly known as red dot), so it is about building on this. Three volunteers from this group were needed to work with DIAG. TOR, BS and LF had previously volunteered. A draft is slightly behind. Hoping that a draft will be sent to the group next month.

- 3.5 *Minute 12.1* – Workplan Review – There was a question as to whether there are any plans to re-activate advanced/consultant accreditation and TOR informed the group that an appointment has been made to replace Jacquie Vallis, and they will be starting on 1<sup>st</sup> July, so accreditation will reconvene, it is anticipated that will be starting with Assistant Practitioners (as these has the highest number of applicants), followed by Advanced Practitioners and finally Consultant Radiographers. It is hoped that all accreditation software should be available by the end of summer. It was noted that the re-accreditation process is currently on hold and accreditation has been extended for those who have been unable to re-accredit (since the system had not been available). TOR will keep the group updated.

Deputy Chair – Helen Yule has kindly volunteered for the position of deputy chair. Thanks were offered to Helen.

### 5. **REVIEW OF CRAG WORKPLAN**

- 5.1 The group discussed the workplan and targets. YT asked the group if there were all okay with the four headings of the workplan and everyone agreed that they were.

5.1.1 SC gave an update on the guidance document (Support of New and Established consultant radiographer roles) that she, LD, NR and a small working party are progressing. Thanks for the feedback received. She mentioned that LF asked for remote working to be added. A discussion followed and it was felt that a paragraph to encompass flexible working and work-life balance be added into the job plans. Some attendees felt that flexible working helps to maintain mental health. SC is happy to draft a statement on flexible working to be incorporated into the job plan.

5.1.2 There was also a question around personal CPD and where does it fit, and this was discussed. Some members incorporated their CPD into everything they do. Others put time aside to do this, but some members felt that CPD should be overt in their job plan. It was agreed that SC would draft a statement and share with CRAG within the next week or two. From there it will go to Council for sign off. SC will aim to have the document ready to go the UK Council meeting on 18<sup>th</sup> May.

NR queried the timeframe for the ECF, and TOR informed him that the document would be going to the May Council meeting for sign off and then publication. To note that active involvement in research is an element threaded through each step of the framework.

5.2 A CRAG virtual Q&A session, held for the wider consultant network, had forty-three members attend. The session was open to advanced and consultant practitioners who posed a variety of questions, and positive feedback received. It was felt that this session went well on the day. Moving forward, the group plan to repeat meetings online every few months.

5.3 Engaging with all advisory groups – TOR informed the group that she had spoken with Alex Lipton around the importance of managers as gatekeepers and CRAG could invite one of the managers to a meeting. TOR suggested the group also consider arranging to go along to the Quality Standards for Imaging (QSI) group who are on the NHS platform, to speak to them about CRAG and consultant radiographer roles in practice.

SW indicated that she currently had little direction from management with respect to her consultant role. Following discussion, it was strongly suggested that the upcoming guidance document should disseminated and promoted among the managers group.

- 5.5 YT indicated that due to pressure of work, he has not had time to contact the research advisory group, but he will engage as per workplan and give feedback by the end of this month.

### **7. HEE WORKSHOPS – DEVELOPMENT OF ADVANCED PRACTITIONER TO CONSULTANT LEVEL PRACTICE**

- 7.1 TOR informed the group that the centre for advancing practice put a call out to say they were doing workshops looking at the development from advanced to consultant practice for specific areas – learning disability & autism, cancer, and MSK. Officers at SCoR applied to join different workshops, which were very interesting to attend. A multi-professional range of people attended. There does appear to be a lot of funding now with an aim to develop the workforce in England. TOR encouraged groups to apply for this funding for relevant advanced practice roles.

Following the HEE workshops, an overall report is being written and as soon as she gets this TOR will share with the group. LF queried whether this funding money was for the cancer workforce or just in general. TOR indicated that the main focus has been on advanced practice to consultant development for learning disability & autism, MSK and Cancer. YT asked HY if there is anything similar happening in Wales but so far no.
