Our vision is for a thriving health education and research sector delivering a high-quality nursing, midwifery and allied health professional workforce.






Our member universities deliver the future healthcare workforce of the NHS, charitable and private sectors.



Significant challenges facing universities...

• Financial sustainability crisis:


"...significant numbers of universities will face deficits by the end of 2025-26. A smaller proportion also face liquidity problems, with our modelling projecting nearly one in six institutions will have less than 30 days' liquidity"

- Cost of delivery: tuition fee loan real terms reduction
- International students indirect impact on domestic fee cross-subsidy and knock on effects in domestic recruitment
- Increased running costs
- Academic workforce pressures restructuring, impact on student support

The declining value of the tuition fee loan

Nominal and real fee cap values




U/G fee cap introduced at £9,000 in 2012.

Raised to £9,250 in 2017.


Recently announced inflationary uplift to £9,535.

After effects of inflation tuition fee now worth about £6,300 in real terms compared to 2012



... implications for health education delivery...




- Cost of delivery unsustainable
- Limited ability to invest in facilities for eg expansion or simulation
- Some of the institutions with largest health provision facing significant financial challenges
- International students indirect impact via domestic fee cross-subsidy
- Academic workforce pressures
- Restructuring tensioned against regulatory rigidities (eg mandated SSRs)
- Risks to strategically important (national/regional) provision



Pulling in the same direction (or not)?

- Two big policy papers in last few months:
 - 10 Year Health Plan and workforce plan
 - Post 16 Education & Skills White Paper
- Missing pieces eg social care?
- Are the incentives for students, universities, colleges and employers aligned?
 - Employment challenges for recently graduated health professionals
 - Educator workforce
 - Placement capacity
 - Level 7 Apprenticeship funding




Post-16 Education & Skills White Paper

- Tuition fee uplifts in line with inflation
- Introduce Lifelong Learning Entitlement
- Maintenance loans linked to international student levy
- Reform OfS Strategic Priorities Grant
- Research specialisation
- Increased collaboration across the education sector
- Stronger role for OfS


10 Year Health Plan

- The plan sets out how the government will reinvent the NHS in England through three shifts:
 - hospital to community
 - analogue to digital
 - sickness to prevention.
- Reorientate the focus of NHS recruitment away from international recruitment and towards its own communities; supporting those unemployed or economically inactive into appropriate roles
- New workforce plan being developed by Spring 2026 – assumption that changes to healthcare delivery will require different workforce strategy
- Address significant culture issues to make NHS an employer of choice



10 Year Health Plan - specifics

- Overhaul education and training curricula
- Reform placement tariffs and quicker reimbursement of placement costs for students
- Create 2,000 more nursing apprenticeships over the next three years, prioritising areas with the greatest need
- Development of advanced practice models for nurses, midwives, and allied health professionals, particularly in neighbourhood settings
- Address student attrition
- Reverse the decline in clinical academic roles through collaboration between government and major charity funders
- Increase research opportunities for nurses, midwives and AHPs.



Moving forward

- What do the shifts to community / preventative/ digital mean for future education curricula and placements?
- Education as part of a wider health workforce ecosystem, not just a supplier of trained labour for the NHS
- Capitalise on recognition of importance of research and clinical academics







Opportunities... new Workforce Plan as a platform for collaboration

- Provides a framework for how the sector might evolve including expansion of apprenticeship delivery and curriculum development
- Could be used to create coordination around supply both regionally and for specific professions
- Drive culture change in the NHS to value and support learners and educators
- Could provide confidence to allow investment to support expansion in facilities and technology (eg simulated learning environments)
- Signals intent to invest in clinical academic careers and research in NMAHP areas
- Strong emphasis on social mobility and local provision will resonate with many HEIs & colleges

Opportunities... Post 16 Education and Skills White Paper

- Restores principle of inflationary increases to tuition fee loan
- Limited introduction of maintenance grants (at a price)
- Encourage collaboration between Higher and Further Education
- Continued emphasis on access and participation, with reduced bureaucracy for those delivering on this agenda
- Lifelong Learning Entitlement offers flexibility to learners
- Improved cost recovery for research
- Reform of REF
