BALLOT ON A POLITICAL FUND

Our Independent Scrutineer's report of voting in the above ballot, which closed at noon today, is as follows.

Number of voting papers distributed for the purposes of the ballot:	27954
Number of voting papers returned to the scrutineer:	6664
Turnout:	23.8%
Number of votes found to be spoiled or otherwise invalid:	3
Total number of valid votes to be counted:	6661

THE RESOLUTION is that the political objects set out in section 72 of the Trade Union and Labour Relations (Consolidation) Act 1992 (reproduced overleaf) be approved as an object of the Union.

Do you vote in favour of the Resolution?

Number of valid votes cast for the resolution	6193	(93%)
Number of valid votes cast against the resolution	468	(7%)

The ballot papers will be stored in accordance with the requirements of the Trade Union and Labour Relations (Consolidation) Act 1992 (as amended by the Trade Union Reform and Employment Rights Act 1993).

Rights Act 1993), we are satisfied as to each of the matters specified in subsection 78(2) with regard to the ballot. The following points should also be noted:

- 1) The person appointed under section 77A to carry out the storage and counting of voting papers was Electoral Reform Services Limited.
- 2) The person appointed under section 77A to carry out the distribution of the voting papers was Electoral Reform Services Limited.
- 3) A copy of the register of voters (as at the relevant date) was examined in accordance with section 78(2A)(i). The examination took place at our own instance and did not reveal any matter that should be brought to the attention of the trade union.

We draw your attention to sections 78(4), 78(5) and 78(6). Section 78(4) requires that a copy of this report be published and made available to all members of the union within a three-month period from today. This however, does not mean that every member has to be notified individually.
