SOCIETY OF RADIOGRAPHERS BENEVOLENT FUND TRUSTEES REPORT FOR THE YEAR ENDED 30 SEPTEMBER 2024

The Trustees present their report and the independently examined accounts for the year ended 30 September 2024.

AIMS AND OBJECTIVES

The Benevolent fund was established in 1983 as a registered charity and is governed by a trust deed dated 16th June 1983, a Supplemental Deed of Trust dated 23rd November 2006 and a deed of amendment dated 11th July 2024. The objects of the charity are "the assistance and relief of persons in the United Kingdom being members (including student members) and former members of the Society and their dependants who are in necessitous financial circumstances and in particular such of them as are old, sick or incapacitated."

PUBLIC BENEFIT

The Trustees have paid due regard to the guidance on public benefit published by the Commission in exercising their powers and planning the activities of the charity. The Trustees are satisfied that the Trust has charitable purposes as set out in the Charities Act 2011 covering the prevention and relief of poverty for the public benefit.

There were three new Trustees appointed during the year and Christine Blakeley stepped down during the year. The responsibility for the overall management and organisation of the charity rests with the Board of Trustees. The Board comprising of seven Trustees are appointed by Society Council. (Note: Numbers exclude the Chair of the Board). Policies and procedures, together with a Handbook for the induction and training and guidance of trustees have been prepared and currently this is conducted according to need.

ACTIVITY IN THE YEAR

The Trustees met three times during the year to discuss management of the Fund and strategy. Requests for assistance and the awarding of grants are regularly discussed via an online facility. Other activity during the year included attendance at UKIO, ADC and the rep's summit to raise awareness of the fund, as well as distributing marketing materials. Receipts for the year to September 2024 were £20,248, £11,397 more than 2023 mainly due to the receipt of a £7,500 legacy (nil in previous year) and increase of bank interest of £9,842 by £4,649 from £5,193 in the previous year. Donations decreased by £590 from £3,496 last year to £2,906 in the current year which was mainly due to a timing difference of the transfer of this year's ADC £735 donation in November 2024.

Payments in the year amounted to a total of £8,618 compared to £14,137 in 2023. The £5,519 fall was mainly due to a decrease in value of awards as the number of awards of three remained unchanged from the previous year combined with a £1,776 fall in sundry expenditure from £3,868 to £2,092 mainly relating to governance costs. The total awards value during the year fell to £5,210 by £3,966 from £9,176.

The value of the investment fund increased during the year by £5,301 from £52,209 to £57,510. The short term deposit balance at 30 September 2024 was £260,869 and the Fund's bank balance was £19,305. The aggregate of £337,684 represented an increase of £16,931 over the total of the balance of the year before.

The Trustees would like to thank the fundraisers and all those who have made donations in the year or otherwise supported the Fund.

INVESTMENT, RESERVES AND RISK POLICIES

Investment

The Abrdn Multi Manger Fund aims to achieve long term capital growth in excess of inflation through investment in a wide ranging portfolio. This will be kept under regular review and an agreed investment policy has been adopted in order to safeguard the capital resources of the Fund. The policy considers the level of risk of the investment strategy, investment management selection, investment restrictions and its responsible investment policy which precludes investment in armaments and tobacco stocks. The investment policy is regularly reviewed and was updated during the year.

Reserves

The charity's cash reserves, excluding the investment fund, amounted to £280,174 at 30 September 2024.

The Trustees wish to hold sufficient reserves to be able to ensure continuity in the operation of the charity in the event of a large variation of income and/or increase in applications for financial assistance. To address this inherent uncertainty the Trustees deem it prudent to aim to hold the equivalent of two years planned expenditure for financial assistance in a readily accessible deposit account and three years planned expenditure for financial assistance equivalent on deposit on appropriate (<2years) notice. This level of reserves will allow charity to cover its liabilities, any unforeseen contingencies and absorb setbacks. Unrestricted funds remaining beyond the reserves requirement should be invested in line with the Benevolent Fund Investment Policy.

Risk

The Trustees have reviewed the major risks facing the fund at each meeting.



SOCIETY OF RADIOGRAPHERS BENEVOLENT FUND NOTES ON THE FINANCIAL STATEMENTS FOR THE YEAR ENDED 30 SEPTEMBER 2024

1. ACCOUNTING POLICIES

The principal accounting policies adopted in the preparation of the Benevolent Fund's accounts are as follows:

a) Accounting treatment

The financial statements have been prepared on a receipts and payments basis.

b) Payments

Awards are granted to individuals and not institutions. None of the Trustees are remunerated.

2. TAXATION

No provision for taxation is required on these accounts.

3. RELATED PARTY TRANSACTIONS

The Society of Radiographers has the power to appoint members of the Board of Trustees of the Society of Radiographers Benevolent Fund and therefore both are related parties. The Society of Radiographers incurred £3,054 in relation to an outsourced administration solution.

The Society of Radiographers provides administration support to the Society of Radiographers Benevolent Fund's Board of Trustees

4. Gift Aid due

Gift Aid of £855 is comprised of both tax years 2022-23 and 2023-24. £162 Gift Aid claimed in the previous year relates to tax year 2021-22.

5. Due from the Society of Radiographers

The Society is due to pay the Benevolent Fund £535, which is net of the donation of £735 from the ADC raffle tickets sales and a transfer correction of £200.

6. Trustees Expenses

£74 of travel expenses were incurred during the year (2023: £25).

7. Restricted Funds - Covid-19 Healthcare Support Appeal

The Covid19 Healthcare Support Appeal (CHSA) had been setup to fund projects that support health care workers during and after the Covid19 pandemic. It was part of the RCN Foundation. Funding was provided to fund support which might include physiotherapy, counselling, and/or other support and wellbeing service. In November 2023, permission was granted by the donor to transfer the remaining balance of £475 to unrestricted funds.
