# **Minutes from Previous meeting**

### **Matters Arising:**

### **Training for Reps**

IC informed the Forum that he is hoping to make the regional H&S reps training more interactive and virtual meetings are likely to continue until the New Year.

It is hoped that the Stage 3 TUC Diploma course will be completed by December. The scheduled presentations at Hillscourt in November have been pushed back to January, when it is hoped the course will be concluded. If it is not possible to attend Hillscourt in January the course and presentations will be completed virtually.

Advertising of the next Stage 3 course has been delayed due to Covid.

All training is being kept under review. Topics for future training are likely to be Working Time Directive, Shift Working – to include the NHS Employers infographic which is now available via the SoR website.

Approximately 8 new H&S reps have informed us that they have signed up to complete the TUC Stage 1 course.

It is hoped that the SoR will return to offering the residential induction courses at some point, when restrictions allow.

### **APs/Apprenticeships**

LJ reported more universities are to offer academic places going forward. Students are treated as staff and risk assessed in the same way due to Covid.

### **Personal Injuries:**

IC reported a case which had won a large settlement of £115,000. 9 new cases had been received, 8 of which as a result of this article which was reported on the website, with 10 claim forms still to be returned. Although some claims were either out of time or it was felt that the employer had not breached their duty of care. One case was turned down.

# Items for Discussion:

### Feedback on Covid-19

SPF meeting – IC - no changes to report. PPE remained on Agenda. The next meeting is in a weeks' time. A presentation was given at the last meeting on the NHS Track and Trace APP, which is due to be launched at the end of the month.

Very few Covid-19 related cases had been reported to IC.

LI reported that she has been working with a rep concerning a pregnant member of staff who has told she cannot work. There is no continuity with how pregnant staff are dealt with across the Trust.

All students have to be risk assessed via virtual meetings before they can start placement.

JH reported that pregnant staff are carrying out non-contact duties.

IC reported that some cases had been received when shielding guidelines were relaxed.

LJ reported that no issues had been raised with staff returning after shielding, which was dependant on their role before Covid.
