

EFRS Patient-Centred Care Awards

The EFRS Patient-Centred Care Awards 2021 have now launched!

The EFRS Patient-Centred Care Awards aim to recognise, celebrate, and promote the work of radiographers in improving care through a patient-centred approach.

Entries are now open for the EFRS Patient-Centred Care Awards 2021. Radiographers, who are members, of National Societies and Educational Institutions affiliated with the EFRS can enter as individuals or as part of a team. Entries will provide a description of a project or case study which must have a clear focus on enhancing patient care.

EFRS Patient-Centred Care Awards 2021 winner and runner-up will be receive:

- An EFRS Patient-Centred Care Award certificate
- Promotion of their winning project by the EFRS
- A prize of €300 to the winner and €150 to the runner-up



Application Process

Thank you for considering entering the EFRS Patient Centred Care Awards 2021. The aim of the awards is to celebrate the impressive work that radiographers do across Europe, and to raise awareness of the projects that drive forward high-quality patient care.

The 2021 awards will have a two-stage entry process.

Stage 1:

The first stage is a short abstract submission describing your project or case study which must have a clear focus on enhancing patient care. Abstracts must be submitted via an online form by 17:00 CET on April 16th, 2021. From these entries a short-list will be selected for Stage 2.

The Stage 1 applications will be adjudicated be a panel composed of patient representatives and members of the EFRs Patient-Centred Care Working Group. The adjudication panel will be chaired by the EFRS president.

Stage 2:

Individuals or teams short-listed for Stage 2, will then be required to submit an electronic poster (single A4 portrait PowerPoint slide or maximum 2-minute short video equivalent), in English, showcasing their project and aimed at both professionals and patients / the public. This must be submitted by 17:00 CET on May 28th, 2021. Submission details will be sent to all short-listed for Stage 2.

The adjudication of these electronic posters will involve a panel composed of patient representatives and members of the EFRs Patient-Centred Care Working Group. The adjudication panel will be chaired by the EFRS president.

All electronic posters will be published online, and the winner and runner-up will be decided through a combined score from the adjudication panel and a public vote. Submissions will be judged according to the following criteria:

- Achievement
- Impact of achievement
- Alignment with the values and objectives of the EFRS
- Sustainability

Eligibility:

To enter the EFRS Patient-Centred Care Awards, you must be a member of, or employed by, an EFRS affiliated National Society or Educational Institution. To confirm your eligibility, you can see a list of member institutions on <u>www.efrs.eu/members</u>. Candidates should also submit proof that they are a



current member of National Society which is a current member of the EFRS. Projects which have previously received an award should not be submitted.

Please note that all applications are self-nomination only, however, all must provide details of a single referee.
